Health & Fitness Fair - Came off fairly well in spite of rain. Made about \$1000 primarily from sponsors fees and vendor participation. Town helped with traffic control.

Members Town Hall - May 17 - Attendance a little less than prior Town Hall. Great opportunity to find out what members are thinking. Received a few programming suggestions.

Copier - Copier lease up in July. New copier due any day now.

Office Computers - New computers are installed and running well. Old computers are being evaluated for possible use in the Library. Possibly add two of these computers in the library for specialized uses. There are already two relatively new computers in the Library. The unused old computers will be recycled. They are not of much value.

Surplus Property - Stashed all over the building will be cleaned out. Most has little or no value. If not saleable will be surplus and out.

Masks - Some senior centers still mandate masks for everyone. Other considerations include if sick stay home, if not vaccinated wear mask and socially distance. Town employees currently wear masks to meet NYS guidance. Checking temperature doesn't always work. Still must wear mask in medical settings, public transportation, and places where people are close together. Honor system is only reasonable approach. Checking people is time consuming. Following discussion and related comments, motion to allow fully vaccinated people to enter the Center without a mask, advise unvaccinated to wear mask and socially distance both on the honor system made by Paul Schulz. Second by Jeff Buckley. Voting on mask motion aye (8) Adams, Blum, Buckley, Gettings, Meacham, Ruhland, Schulz, West. Voting nay (0). Voting abstain (0).

Motion carried unanimously.

Executive Director comment that Center will start with this policy immediately.

Capacity - Room limits are still in effect. Hope to raise capacity to 30%. Still need social distancing option for people who are not vaccinated. Outside capacity is higher.

Committee Meetings - There was an issue regarding operating when there were not three fully appointed and Board approved Board members on the Finance Committee. The Bylaws require three Board members on each committee.

Quorum is based on all appointed and approved Committee members. The quorum does not require the presence of Board Committee members. There must be enough committee members present to meet the needed quorum number with or without Board committee members.

PPP (Payroll Protection Plan) - \$44,000 Has been forgiven. Funds were used to cover payroll. Some concern regarding how this is reported in Financial Statements. The funds began as a liability (loan) and became income (a grant) from the US Government when the loan was forgiven. The stipend from the Town was resolved (modified) last year based on the expectation of the PPP becoming a grant.

Financial Reports - Committee agreed that Balance Sheet and Profit and Loss Statements should be received by the Committee and the CSCI Board.

OLD (unfinished) BUSINESS -

Non Clarence Resident Members - We've discussed this for over a year. Board Chair asked the Executive Director (ED) to describe what is done at other Senior Centers in the region regarding non resident membership.

ED reviewed details of costs and privileges that were available at other Centers in the region that are all Town departments.

Most do not receive a stipend from their town. (town employees & town buildings)
There are many alternatives used including resident and non resident dues, fees for all
programs, couple dues, no dues/all fees, lifetime dues, etc. Virtually all county senior centers
allow non resident participation on some basis.
ED would like all members to be treated equally.

Comment covering existing CSCI Policies that allow Erie County residents to participate in all County programs at the Center including the popular Nutrition and Band Exercise programs. Other CSCI policies allow non residents to utilize available space in all other programs with a related fee. A significant point in the extensive discussions was related to Town of Clarence funding of Center operations and controlling appointments to the Board of Directors.

The position or policy of the Town of Clarence regarding non resident participation in a wide range of Town supported things from activities to parks to bike paths is very important. There are currently a number of non residents using Clarence pickleball courts.

ED expects non resident membership would probably be less than 10% of total membership. Non residents can help make programs more vibrant and make some programs viable. Non residents help increase value of fundraisers.

Executive Director would like the related Policy for the class of non Clarence resident Clarence Senior Citizens Center membership to be clean and clear.

A Board decision to allow non resident members requires changes to Bylaws and policies. A policy can be revised at any Board meeting. Bylaws amendments require a Board approval to post for 21 days before a final Board vote on the amendments. This means two Board meetings time must elapse after the proposed Bylaws amendments are prepared and presented.

Motion to allow a non Clarence resident Center membership with annual dues equal to 150% of Clarence resident dues and adjust related Bylaws and Policies accordingly made by Paul Schulz. Second by Jeff Buckley.

Change would be effective when the Bylaws amendments are approved by the Board. Voting to approve the motion regarding non Clarence resident members aye (7) Adams, Buckley, Gettings, Meacham, Ruhland, Schulz, West. Voting nay (1) Blum. Voting abstain (0). Motion carried.

Bylaws Committee to prepare amendments for Bylaws and related Board Policies for next Board meeting. Proposed Bylaws amendments must be posted for 21 days prior to final Board vote on approval.
